April 27th - Final **Registration Day** For All Men 45-65 Years of Age

The registration of "All men, on April 27, who have attained their fortyfifth birthday on or before February 16, 1942, and have not attained their sixty-fifth birthday on April 27, 1942," was announced by National Headquarters, Selective Service System.

Registration cards will be buff in color.

In its memorandum to State Directors, National Headquarters pointed out that as the men of the fourth registration are not liable for military service, there will be no National Lottery for them and no order numbers issued although serial numbers will be placed on registration cards by local boards.

The questions pertain to the registrant's name, place of residence, mailing address (if other than place of residence), telephone, age in years and date of birth, place of birth, name and address of a person who will always know the registrant's whereabouts, his employer's name and address, and the place of his employment or business.

Commander Herman asks that all Legionnaires and Auxiliary members who can do so, volunteer to assist the local draft boards, with the registration, Saturday, Sunday and Monday, May 25, 26 and 27.

Guy Tetirick will head a committee that will contact eligible registrants who are invalids at home, or in hospitals, also those men being held in jails. The committee will have headquarters at the Legion Hut.

Draft Board No. 1 will be at the Legion Hut.

Draft Board No. 2, Civilian Defense Headquarters, Sixth at Main.

The Legion Auxiliary will assist Draft Board No. 2. Draft Board No. 3, 316 National Bank of Tulsa building; and basement, Elks Club, Third and Boulder.

Draft Board No. 4 will be at the Board of Education building, 410 South Cincinnati.

Board No. 5—Third floor Folk building, Sand Springs; and Post Office building, Jenks.

Board No. 6 — Community building, Skiatook; old City Hall, Dawson; and at Collinsville.

Board No. 7—Brown's Service Station, Bixby; and Community Hall, Broken Arrow.

Registration offices will be open 8 a.m. to 6 p.m., Saturday and Sunday; and from 7 a.m. to 9 p.m. on Monday, the final day.

All those desiring to serve, please report at the nearest draft board address given above, Saturday, Sunday, or Monday, for duty.
