The U. S. Navy has opened enlistments, with ratings, for men with construction experience for enrollment in Class V-6 of the Naval Reserve for assignment to headquarters and construction companies in a Construction Regiment. These headquarters and construction companies are comprised of clerks, draftsmen, mechanics, etc., for shore duty at Naval bases outside the continental limits of the United States. Acting appointments are made in various ratings up to and including Chief Petty Officer, depending upon the age, experience and other qualifications of the personnel enlisted.

The enlistment period is for the duration of the war. The salaries for these enlistments range from \$36.00 to \$99.00 a month and include housing, food, clothing, transportation, medical and dental care, and other incidentals, to which enlisted personnel are entitled. An allowance of \$34.50 is provided in the case of a dependent for ratings of petty officer, 2nd class, or above. However, not more than one dependent may be claimed.

If you are interested in such enlistment, it is suggested that you apply to your nearest Naval Recruiting Station for medical examination.

Impressive Ceremony Will Be Broadcast Over KTUL

The Legion committee in charge of arrangements are Joe Lynn, chairman; Glenn Condon and Eddie Gambill. Wm. T. Calvert, chairman of the Tulsa County Civilian Defense committee will receive the flags on behalf of his committee.
