8. Effective outlawry of war and of armed force menace; eventual reduction of armament burden.

## Legionnaires to Receive Registration Awards

### General Hershey Pays Tribute To Volunteer Workers

Washington, D. C.—Legionnaires volunteering to assist examiners in the pre-induction examinations under selective service calls will be rewarded with certificates of appreciation issued in the name of the President, according to a memorandum issued by General Lewis B. Hershey, director of the federal selective service system.

In his memorandum, General Hershey paid this tribute to volunteer Legion workers: "Since the inception of selective service, the director has noted with interest and appreciation the services being performed by various members of The American Legion throughout the country in assisting in the physical examinations and other duties incident to the administration of selective service."

Issuance of the certificates of the President is to be left to the discretion of state directors of the selective service system.

High Mark Reached  
In Membership

Indianapolis, Ind.—For the second  
year, The American Legion during  
1941 smashed all previous member-  
ship records and established a new  
enrollment peak. Its Auxiliary, the  
Forty and Eight, and the Eight and  
Forty, also set new high membership  
marks.

During 1941 the Legion also ex-  
panded by 75 new posts, bringing the  
number of posts to 11,790, a new  
record. The auxiliary also reported  
expansion of its units to 9,351, a new  
high; 40-8 membership, 45,139, a  
new high; 8-40 membership, 7,810,  
a new high; S. A. L. membership,  
53,892.

against spies and saboteurs.

Barring aliens on all defense pro-  
jects and in the merchant marine.

Urging the Selective Service to  
place aliens in same category as con-  
scientious objectors.

Immediate investigation of possi-  
ble subversive activities of all who  
may be connected in any manner  
either as enrollees, employees or un-  
compensated personnel at military  
training camps under the Selective  
Service Act.

Washington, D. C. — Following closely upon a conference with the President at the White House, National Commander Lynn U. Stambaugh told the assembled National Defense Committees of The American Legion that "the President has recognized the worth of The American Legion" in the civilian defense work it has been conducting.

National Commander Stambaugh, with Dean James M. Landis, newly appointed executive of the OCD, consulted the President about new plans to utilize the manpower of the Legion in perfecting civilian defense forces in time of war.

The Commander indicated that Dean Landis paid tribute to the manner in which the Legion had performed in the New England area, where he (Landis) had been regional director of the OCD prior to his coming here to accept the new appointment as executive of the OCD.
