Employment Week

MAY 3rd-9 h

The American Legion has been sponsoring a national employment week in the Spring of each year. In 1942 this week takes on added significance in our view of the necessity of placing every available person in the job where he or she will most contribute to the war production effort. This means, in effect, that industry should rigidly adhere to its formerly expressed position — that there shall be no arbitrary discrimination in employment based on age limitations, race, sex, or organization membership.

American industrialists are gratified to know that The American Legion has also been taking the position that there should be no arbitrary discrimination based on any of those factors in war industry employment. Full employment in the nation's productive effort means, moreover, that every endeavor should be made to put the right worker in the right job, and to provide training for people who have not formerly been employed, those who have not been employed for some time, or those who must shift from one type of employment to another. It will also prove necessary for industry in many instances to modify its rigid physical qualifications for employment and it is especially important that suitable alterations be made in state workmen's compensation laws which will not prevent such action by employers.

Universal Service Bill

The new wartime universal service bill of the American Legion, introduced jointly in the Senate and the House of Representatives of the Second session of the 77th Congress, April 21, is only six paragraphs long, and contains less than 500 words, but covers in broad outline every possible aspect of all-out national mobilization for victory with an effort to provide equality of service for all citizens, and special privileges and profits for none.

House Bills

Four bills in which the American Legion is interested and which have had the close attention of the national legislative committee have been ordered favorably reported by the House committee on World War Veterans legislation.

H. R. 6824 would make temporary disability ratings permanent after having been in effect for ten years. The bill supplants H. R. 1441.

H. R. 2226 by Mr. Bates of Kentucky defines "misconduct" under Veterans Administration regulations as "misconduct when it is due to felonious misconduct." (A national convention resolution supports this measure).

H. R. 6646 by Mrs. Rogers of Massachusetts provides that seven years unexplained absence by a veteran may be regarded as indicating his death, and as cause for payment of benefits accordingly.

The Legion took no position regarding H. R. 4402, a bill by Mr. Rankin of Mississippi to extend five year level-premium term insurance for an additional five year period. (The Milwaukee convention did not pass a proposed resolution calling for such further extension).

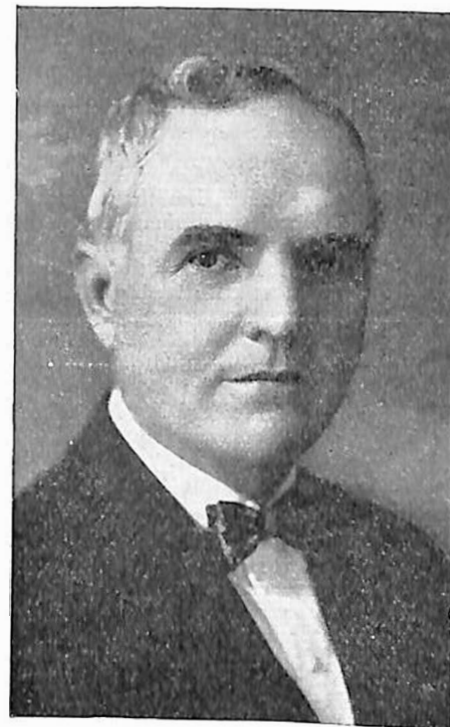

ing hot coffee, guard duty, searching parties, and taking care of the injured or dead. Our 40-8 box car was used as a mobile kitchen, feeding the workers and guards.

Tuesday morning the relief committee composed of Joe Lynn, Leslie Spain, Bob Peacock, Walter Summers, Barney Pascoe, Alex Faulkner, Toots Wayburn, Sam Griffin, A. L. Wells and George Kyger, left early in the morning for Pryor, using the box car to take over several hundred pounds of ice, 50 dozen doughnuts, and other supplies. On reaching Pryor, the box car was again pressed into service as a mobile kitchen for the Red Cross, WPA and Salvation Army. The committee members serving in many and various capacities. On Wednesday morning, H. N.

Man Power Commission

A new War Manpower Commission has been created by the President by executive order, with Paul V. McNutt, Federal Security Administrator and a past national commander of the American Legion, as chairman.

The order places large power and responsibility on McNutt's shoulders, making him America's top man for the mobilization of labor to win the war. McNutt thus emerges apparently head and shoulders above numerous functionaries in Washington who have had, or sought to have, a directive place in organizing the men and women of the country for maximum war production, including Sidney Hillman, labor's representative on the old O. P. M., and even the Secretary of Labor, Madame Perkins. Some of the duties hitherto resting in the Labor Department are transferred to the new War Manpower Commission.
