The Sons of The American Legion is governed in its policy entirely by the mandates of its parent organization, The American Legion. In view of the resolution adopted at the 23rd Annual National Convention of The American Legion on the subject of Communism, and other foreign-inspired isms in this country, The Sons of The American Legion, being an American organization, would not desire to become affiliated in any way whatsoever with Communism or any of its affiliated groups.

The resolutions to which I refer, which were unanimously adopted by the national convention of The American Legion, are as follows:

"RESOLVED by The American Legion in National Convention assembled in Milwaukee, Wisconsin, September 15-18, 1941, that The American Legion's opposition to Communism remains unaltered. We regard Communism, Fascism and Nazism as equally false and dangerous, and urge our members and all our fellow citizens to be constantly on guard to prevent these and all other types of dictatorship from creeping into our midst and undermining our American liberties founded on the Constitution. Approved."

"WHEREAS, our Constitutional Rights of freedom of the press, assembly and speech are the panoply of democracy, and

"WHEREAS, Communism invokes this provision as a mask to cover its sinister attacks and destructive campaign against both state and federal government and loudly proclaims its avowed objective is to destroy by violence existing democratic institutions and supplant them with a despotism patterned on that of Stalin;

"BE IT RESOLVED, that Communism can not be dignified by recognition on the part of the several states as a true political party and must be outlawed. Approved."

The Sons of The American Legion, with more than 50,000 members

throughout the country, will not be duped into becoming affiliated with or cooperating with Communists or any other foreign-inspired youth movement.

We have secured the following legislation for Veterans:

1. Three Hundred Dollars (\$300.00) PERSONAL TAX EXEMPTION.
2. DIRECT CONTACT with the Veterans' Administration.
3. HOSPITALIZATION when applicant presents an Honorable Discharge. Ambulance furnished in vital or emergency cases, WITHOUT COST.
4. SERVICE OFFICER and WELFARE COMMITTEE looks after the family while the Veteran is in the hospital.
5. Government pays \$100.00 for BURIAL EXPENSES.
6. Joe Carson Post Memorial Cemetery—no expense to Veteran's family for burial plot.
7. Government furnishes Burial Flag.
8. Government furnishes a regulation Grave Marker.
9. Legion has Orphans Homes throughout the United States.
(Oklahoma is proud of its Orphans' Home at Ponca City.)

Co-operation With FBI

More than 5,000 American Legion posts have been contacted by the Federal Bureau of Investigation since November, 1940, in the program of co-operation then worked out between it and the commission for co-operation, and more than 42,000 Legionnaires now are voluntarily giving assistance in the effort to make America internally secure, Chairman O'Neil reported. During the coming months the other 6,000 posts will be contacted and the program of co-operation with the FBI further enlarged. Lee Pennington, inspector in the national FBI headquarters in Washington, has been designated to direct the plans of co-operation with The American Legion during 1942.

Chairman O'Neil reported that the commission voted to support the Hobbs Bill now pending in Congress, since Sections 401 and 402 in Title 4 have been stricken from the bill, and voted to authorize the director to lend his assistance to the National legislative committee with a view to an early passage of the bill. This measure calls for the deportation of undesirable aliens.

National Committees

More than 660 appointments on 38 National commissions, boards and committees were announced here November 7, by National Commander Lynn U. Stambaugh, as he completed the 1942 organization of The American Legion for most effective contributions to the country's all-out defense efforts.

All of the appointments were confirmed by the National executive committee.

Four new National committees were created by the National executive committee. Three of these new committees will concern themselves with National Defense matters exclusively. They are the committees on civil defense, on naval affairs, and on the merchant marine. The fourth new committees will deal with the problems of highway safety.

Two National committees passed out of the picture. They were the corps area coordinating committee and the uniform code of procedure committee. The former died a natural death by virtue of the expiration of the terms of all its members who were appointed for one year only. The latter was merged with the constitution and by-laws committee.

New Cap Regulations

Indianapolis, Ind. — All department and county officers of The American Legion who are authorized to wear specially designed caps denoting their offices, are now required to revert to the use of the regulation blue cap upon retiring from their offices.

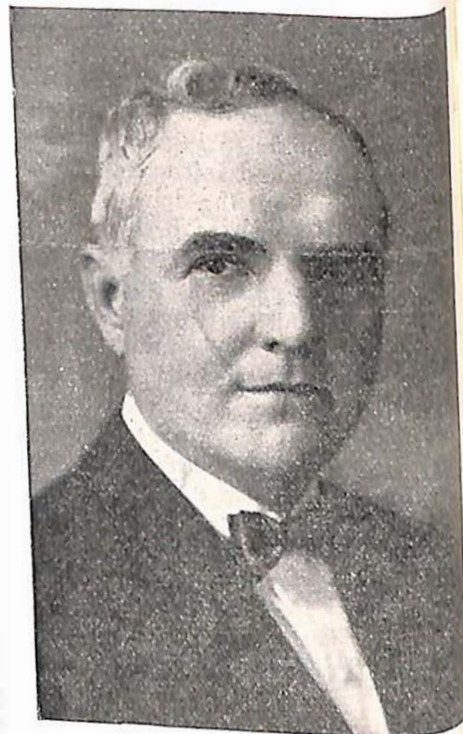
This was the decree of the National executive committee of The American Legion here, November 7, 1941, in adopting the following resolution:

"WHEREAS, considerable confusion and mistaken identity has arisen from improper wearing of Legion caps:

"BE IT RESOLVED, that county officers shall wear a blue Legion cap with white top, and department officers an all-white cap during their term of office, and all members of The American Legion wear the regulation blue Legion cap in accordance with regulations of our National organization.

"BE IT FURTHER RESOLVED, that all department and county officers on retiring from office revert to the regulation blue Legion cap."
