Forty Et Eight Sponsors Spastic Drive

The steady advance in the treatment of spastic paralysis is of great interest to the people of Oklahoma, and to our country in general, and through the work of the Grand Voiture 40 & 8 of the State of Oklahoma this treatment is made possible.

Only a few years ago, it was accepted as a fact that anyone suffering from this terrible affliction was a hopeless case, and there was nothing to be done for it, but today, some of these supposedly hopeless victims are attending our universities, thanks to proper treatment. We now have living proof that by careful and conscientious training many spastics can become useful citizens. At present there are about five thousand spastics in the State of Oklahoma.

The University of Oklahoma, at Norman, recently set aside a building to be used in establishing a training center, but it must be equipped and furnished, and a fund set up for operating expenses.

The State of Oklahoma has a fund at present of \$20,000 which was set aside by the 1947 Legislature to be used toward such equipment, and 40 & 8 is again sponsoring a drive to raise funds for the completion of this purpose.

So many people today are unfamiliar with the meaning of Spastic Paralysis, technically called Cerebral Palsy. It is an affliction whose ravages, like those of infantile paralysis, are visited on children. It is caused by an injury to the brain and can happen before, during or after birth. Today's figures show that of all crippling afflictions, the probable ratio is 15% Infantile Paralysis and 14% Spastic Paralysis. It is the common theory

of spastic doctors that if a child can speak just one word it can learn to talk and if it can take one step it can be taught to walk.

Voiture Locale No. 441 of Muskogee has contributed \$700.00 to the Grand Voiture Spastic Program.

Voiture Locale No. 185 of Tulsa has contributed \$1,000.00 to the Grand Voiture for the furtherance of this work and besides has spent some \$6,000.00 locally and at the present time is sponsoring the treatment of five so afflicted.

James B. Moss, Cheminot National State Spastic Chairman, is working with the various Voitures in the state and it is hoped that in the near future it will be possible to establish centers throughout the state to care for this rapidly growing affliction.
